Incentive Terms and Conditions – Monthly Prize for \$500+ in New Business

Eligibility: Individuals or entities that have an effective Agency Agreement with Peerless Network, Inc. (“Peerless Network”) (“Direct Sales Agents”) and the contractors of entities with whom Peerless Network has an agreement for the sale of Peerless Network products or services on that entity’s sales or master agreement (“Sub-Agents”). Direct Sales Agents and Sub-Agents who sell services or products for Peerless Network between March 1, 2021 and December 31, 2021 (the “Promotion Period”) are eligible to win prizes in this promotion (“Eligible Persons”).
